2. Provide facility support for live fire training exercises.

This position **IS NOT** to be considered as an adjunct instructor or to have any role in the direct training of participants in Live Fire Training Exercises conducted at YCFS.

This is a compensated position and the successful candidate will be paid on a per diem basis as determined by the Live Fire Training Exercises Facilitated.

Candidates for the Position of YCFS Structural Burn Building Facilitator Shall complete and submit an application for the position and must poses the following qualifications: *(copies of certification and Driver's License must accompany application)*

1. Completion Certificates for EBM, or ELIF, or Firefighter I certification, or their equivalent *(as determined by the Board of Governors of the Fire Chiefs' and Firefighters' association of York County)*
2. Valid Driver's License *(issued from current state of residence)*
3. A letter of recommendation from a Chief or Senior Fire Service Official attesting to the candidate's character and ability to take responsibility for oversight of the process.
4. A current Child Abuse Certificate
