Monthly Meeting Minutes

November 16, 2020

CALL TO ORDER (President Chad Deardorff)

President Chad Deardorff called the monthly meeting of the York County Fire Chiefs and Firefighters Association to order at 19:00. The call to order was followed by a pledge to the flag and a moment of silence. 29 people were in attendance.

PRESENTATIONS

White Rose Safety: Wayne Durbin discussed his product line and history. He introduced Mike Bick and Jason Jacoby as factory reps for Drager and Ricochet. White Rose Safety Provided subs, chips, brownies, and drinks for the attendees.

American Red Cross: Judy Rohrbaugh talked about ARC's client services' new direction for dispatching procedure which does not include direct paging any more due to a new policy from the national organization. A regional on-call person must now verify and approve the request for support. In addition, canteen service has been curtailed by the national organization due to civil unrest concerns. APPROVAL OF MINUTES

President Deardorff asked if there were any corrections to last month's minutes. With no corrections, the minutes were approved as issued.

Treasurer (Bob Bowman):

Basic vehicle rescue classes will be added to the website.

Gas props will be available in 2021 and will require a Facilitator to run the props at the same cost as a burn building Facilitator.

911 Center/YCDES (Matt Hobson):

7 new people in training are coming to floor the end of this week. The next class will start Jan 11th.

At the next Board of Commissioners meeting, he will be requesting approval for priority dispatching and protocols.

Chad Deardorff asked about assigned ops channels being monitored for all incidents.

Discussed EMS items and Station-Available status. County is no longer recording when units mark Available in Station. Also discussed pre-alerting and every department getting the same treatment.

Burn instructors met earlier this month to review burn building repairs and additional doors. The group also discussed consolidating and updating usage manuals.
