Fire Chiefs,

It is that time of year again. This is your opportunity to purchase a 2022 York County Fire School Training Subscription. We are again offering a department wide training subscription to our local fire departments. Purchasing just one membership will cover every member in your department to train at our facility from January 1<sup>st</sup> – December 31<sup>st</sup>, 2022.

If your department is planning on using the Burn Building for multiple Live Fire exercises in 2022, I recommend purchasing additional subscriptions. There is no limit as to how many subscriptions a department may purchase. Each department only needs to purchase one subscription to take advantage of the benefits.

The benefits of purchasing a training subscription:

- Student registration for YCFS courses at no cost except for books and supplies/lab fees
- 8 hours of structural burn building use for live-fire training at no cost for building use or materials
- One time use of roof ventilation prop at no cost for materials
- Unlimited use of other props, pump testing area and buildings at no cost (non-live-fire use only)
- Unlimited use of one classroom per training session

We have given you the option of buying a subscription with the facilitator fee included. You can choose this option if you like.

Online you will find a copy of our Facility Usage Request form. We ask that your department contact the Fire School to know the best availability of our facility for your department's training needs. The Facility Usage Form should be filled out and submitted every time your department plans to use our facility. This form needs to be submitted in advance for any Non-Live Fire training requests and 5 weeks for any Live Fire training requests.
