Collapse 99 and Utility 99 designations were approved.

Asked Scott Keener to talk about Crew Force officers in CAD. It cannot assign and send multiple officers on two separate calls. 9-1-1 is proposing programming multiple chiefs from each station into Crew Force in numerical order to overcome this. Troy Dettinger made a motion to approve to table issue until a written policy is presented for review. Tim Stevens seconded the motion and the motion carried.
