The call to order was followed by a pledge to the flag and a moment of silence. 38 people were in attendance, including 10 members of West Manchester Twp Fire who helped with meal prep.

#### **PRESENTATIONS**

Chief Laughman welcomed the association to the fire station. Thank you to all for the meal.

York County 911 regarding the MCU which they brought and they showed a PPT.

#### **APPROVAL OF MINUTES**

President Deardorff asked if there were any corrections to last month's minutes. With no corrections, a motion to approve by Tony Myers second by Tim Steve and the motion was approved.

#### **REPORTS**

#### **Treasurer** (Bob Bowman):

Treasurer Bob Bowman presented the following report: Beginning balance \$6,347.12 with an ending balance of \$6,929.39. President Deardorff asked for a motion to approve the Treasurer's Report. Clif Laughman made a motion, Eric Strittmatter seconded the motion and the motion was approved.

The Board met this evening prior to this meeting and discussed the capital building project. Looking for engineers to come and give us some ideas. More info from Jim. Financially we are stable.

# <u>Fire School Administrator</u> (Jim Pritchard – <u>james@ycfs.us</u>):

Gave the September 2023 Fire School Training Report.

Adding Fire Officer I class and if we get enough people, will add Fire Officer II.

Pump Ops I class, need two departments. Then back to school in fall for Pump Ops II. If interested in hosting contact Jim.

Coarse catalog is now out, check it out on the website.

Looking for see if we can set up the mods classes so the student can sign up for all mods and SBS. Nothing at this point but more to come. There was some discussion about how this would possibly work. Kinsley School of Construction built, donated and installed the ladder rack in the climb tower on first floor. Equipment trailer has been moved, please make sure to keep it organized and put it back the way you found it.

Company level burns, 17 y/o can NOT do interior work on a company level burn. Even if they did an SBS. Last week, April our admin turned in her 2 week notice. Do not expect any interruptions.

Capital building project – working with the engineer to possibly relocate the building and make it a 2-story building, lower level app bay, working area for PD and then upstairs classrooms / showers and

bathrooms. Discussion tonight at BOG to possibly add on to current building to extend over current training building. No matter what, looking at possibly \$2-\$3M.

Working on the fee schedule for no shows but no update at this time.

#### **OTHER AGENCY REPORTS**

# 911 Center/YCDES (Chris Lorenzen):

Technology upgrade, no real effect but it is NextGen911. Fairly big deal of upgrade and will make the 911 calls that are coming into location-based calls. This will go into effect on November 8<sup>th</sup>, 2023. Should be seamless because the agency doing it has been doing it all over the commonwealth.

Staffing update, 6 new hires and 2 from September. Possibly 8 starting in November.

Call processing time discussion – Radio work group asked for specific times.

Fire dispatchers took approx. 128 seconds for Priority 2 & 3 and 118 seconds for higher priority. These are average call times.

Time received to call dispatched was, average, 28 seconds.

There are outliers but the bulk of calls are handled in the correct timeframe.

What is the percentage of staffing. Staffed for 68 but are now only at 43 – those are the signed off for 1 month with 1 are signed off.

Brad Dunham asked about the paging on a Thursday morning and Chris said still looking into it. Clif Laughman asked about the voice paging going off of CAD and not usable if CAD goes down.

Chris Lorenzan agreed. Works off of the interface of the CAD. We have not moved so the dispatchers can use it independently. It can be done manually but staff have not yet been trained to do it.

Scott Keener has the pagers locked and won't share passwords and the department cant get into them and they are owned by now the departments.

Again, still no true representation and thank you to Chris for being in attendance BUT, the appropriate representation is not at our meetings and we continue to ask.

Pagers MUST have to be given to the department and Scott needs to stop playing these games.

# <u>ATR</u> (John Sanford - <u>yc.atr@comcast.net</u>):

The ATR team had 6 calls for the month; 38 calls for the year.

Effective October 1, 2023, Hanover Fire Rescue is no longer part of York County ATR.

# **OEM** (Cody Santiago):

# **Haz-Mat** (Dan Santoemma):

The Haz-Mat team had 25 calls for the month; 150 calls for the year.

Advanced meter December 16th with 6 spots left to fill.
