Public Safety Policy Board (Tony Clousher):

Management at the 911 center is still working fixes to address the Crew Force issues.

They also reported they received a score of 9+ out of 10 on an ISO review. I think he said 9.35, but I didn't write it down.

Matt addressed the digital paging and plans for it when it needs replaced. Chris Krichten asked Matt a question about how it will affect us, and Matt stated that their goal is to come up with a plan for the digital paging PRIOR to the current digital paging going out of service. He also stated that the current voice paging will eventually be set up as a backup but right now, it is on the same platform as the digital paging.

Commissioner Wheeler reported that a Resolution was on the agenda at their next meeting to increase the property tax rebate for active volunteer responders to 100%, and other members 50%. She further reported that the Board is going to have the solicitor review if there are any avenues for them to provide or incentivize rent rebates for active responders who don't own a home.
